July 1, 2024 Terms & Conditions, Assumption of Risk, Waiver of Liability

Southern Nazarene University (SNU) with Worth It Moments (WIM)

Trip Dates: April 23 through April 29, 2025

Cost: \$1,575 per person

Price:

\$1,575 is based on shared double room occupancy and includes transportation, entrance fees to sights, and gratuities, and all meals except three. The single occupancy rate for individual travelers without a roommate is \$2,000.

Deposit and Registration:

A non-refundable deposit of \$250 per person is required upon registration. Trip balance must be paid in full by March 3rd, 2025.

Payment Schedule:

Nonrefundable Deposit: Due Oct. 1, 2024

● Couple \$500 ● Single \$250

Second Payment: Due Jan. 15, 2025

● Couple \$1,500 ● Single \$750

Final Payment: Due March 3, 2025

● Couple \$1,100 ● Single with roommate \$550 or without roommate \$975

Refunds Upon Cancellation:

Initial \$250 deposits are non-refundable. The refund cancellation (not including deposit) schedule is as follows:

- I. 75% refund on cancellations made 120+ days before the trip*
- II. 50% refund on cancellations 90+ days before the trip*
- III. 25% refund on cancellations made 30+ days before the trip*
- IV. Cancellations within 30 days of the trip are not eligible for a refund*

Insurance:

Both SNU & Worth It Moments highly recommend purchasing insurance for trip cancellation and interruptions, as well as other insurance like travel medical and AD&D insurance.

Physical Activity/Assumption of Risk:

You acknowledge and agree that the travel will require moderate physical activity such as walking on unlevel or inclined ground, as well as sitting and standing for extended periods of time, and you have made the determination that you are physically able to participate in such activities. Further, you acknowledge and willingly assume the types of risks that can come with such activities and general travel to destinations and situations unfamiliar to you.

Compliance with Laws:

You acknowledge and agree to comply with all federal, state, and local laws and regulations through the duration of the travel. Furthermore, you agree to abide by all directives and instructions of the tour guide and travel personnel.

Waiver of Liability:

SNU and WIM are not liable for any wrongful or negligent acts or omissions by any supplier or third party not directly owned or controlled by SNU or WIM, or by the failure of any equipment operated by any such supplier or third party. SNU and WIM are not liable for any loss, injury, or damage to person or property in connection with any accommodations, transportation or other services resulting directly or indirectly from acts of God, breakdown of machinery or equipment, acts of government, epidemics, pandemics, riots, thefts, strike, or other similar events.

Cancellation by SNU or WIM:

In the event SNU & WIM need to postpone or reschedule the tour due to an event within our control, options will be given for a refund. In the event SNU & WIM need to postpone or reschedule due to an event outside our control, refunds may not be able to be issued.

Acceptance:

The receipt of your deposit will indicate that you have read, understand, and agree to these Terms and Conditions

SNU Specific Terms and Conditions

Informed Consent: I have been informed by the University and am confident that I understand the various aspects of this trip named above, including but not limited to the arrangements for finances, any travel/itinerary, safety precautions, and logistics. I further understand and acknowledge that despite careful planning and supervision, serious injuries, sickness, or disease might occur during this trip as a result of various dangers or risks associated with it. Persons involved may sustain fatal or serious infection, sickness, injury, property damage, or severe social and/or economic loss as a consequence of not only their own actions, inactions, or negligence, but the actions, inactions, or negligence of others, weather conditions, conditions of equipment, language barriers, differing social cultures and laws. There may also be other risks not foreseeable at this time.

Acceptance of Risk and Release of Liability: I accept full responsibility for the foregoing risks of infection, sickness, injury, permanent disability, or death, on behalf of myself or minor participant, if applicable. In consideration of the opportunity to participate in this trip. I release and discharge Southern Nazarene University, its officers, employees, and agents (herein after collectively referred to as "University") from all liability defined herein arising out of or in connection with my participation in the above-described trip. For the purpose of this Agreement, liability means all claims, demands, causes of action, suits or judgments of any kind (including court costs and attorney's fees) that I, my heirs, executors, administrators, assignees, or any other person or entity may have against the University because of my death, personal injury, illness, or for any loss. I hereby affirm that this Agreement shall be constructed in accordance with the laws of the State of Oklahoma.

Indemnification: I, my heirs, successors, and representatives agree not to sue the University and hold harmless, defend, and indemnify the University from any and all liability as described above that may occur due to my and/or minor participant's participation.

Conduct/Behavioral Expectations: I Understand that SNU is Owned by the Church of the Nazarene and has beliefs consistent with the sponsoring denomination. As a participant in this trip, I agree to respect these guidelines and I will abide by the expectations of this community while on the SNU campus or representing the SNU Community outside of campus.

Medical Consent: In the event of any medical emergency, I authorize and consent on behalf of myself and/or minor participant, to any x-ray examination, anesthetic, medical, dental, or surgical diagnosis or treatment and/or hospital care deemed necessary for my safety and protection.

Use of Image and Sound: I understand that the University may photograph, video record, and/or audio record me and my activities during my participation in the Trip/Event/Programming. I further understand that the University may choose to use any such recordings and/or images at their sole discretion for promotional or other purposes.
